



Lakeview Elementary School Title I Parent and Family Engagement Policy 2020-2021

Part 1. POLICY ENGAGEMENT

Lakeview Elementary School will:

 - (C) if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible; and
 - (D) Parents may obtain information via the Parent newsletter, school's website and Parent Dojo. Academic performance expectations and progress is shared with parents through progress reports, report cards, PowerSchool, and benchmark letters each quarter.
- (5) If the schoolwide program is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the local educational agency. (if applicable)
- (6) Lakeview Elementary School will provide parents the opportunity for regular meetings at times convenient for them to formulate suggestions and make decisions relating to the education of their children through parent-teacher conferences, Child Study Meetings, and through parent-administrator conferences.

Part 2. SHARED RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT

School Responsibilities

Lakeview Elementary School will:

- 1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the state's student academic achievement standards as follows:
 - By following the curriculum provided by the VDOE and Portsmouth Public Schools.
 - By providing supplemental programs: After-school tutoring and workshops.
- 2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:
 - Parent conferences will be held at least once a semester
 - Conferences will be held through the year with parents of students experiencing difficulty academically.
 - Parent participation is documented on the contact logs.
- 3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:
 - Parent receive progress reports every 4 ½ weeks, report cards every 9 weeks, and benchmark reports each quarter.
 - Parents receive communication folders weekly with work samples and updates on student performance

- 4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents virtually before school, after school, and during planning periods each day.
- 5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

Part 3. BUILDING CAPACITY FOR Engagement
